

OFFICIAL RULES OF “ZOOKEEPER FOR A DAY” SWEEPSTAKES (the “Sweepstakes”)
SPONSORED BY MARYLAND 529

No purchase necessary to enter or win. A purchase does not increase your chance of winning. Void where prohibited.

SWEEPSTAKES DESCRIPTION: The Sweepstakes period begins on May 22, 2017 and ends on June 23, 2017. Mail-in entries must be received by 5:00 p.m. on June 23, 2017. A random winner will be drawn as soon as practicable after June 26, 2017. The odds of winning the Sweepstakes depends on the number of eligible entries received.

PRIZE/ACTUAL RETAIL VALUE: One (1) prize of \$529, which will be in the form of a Maryland College Investment Plan (“MCIP”) account (the “Prize”), will be awarded to one winner. If the winner already has an active MCIP account, the \$529 will be deposited into the winner’s account. If the winner has multiple MCIP accounts, the \$529 will be directed into the account that the winner indicates. In addition, a Behind the Scenes Zoo experience for a group of up to six (6) (\$500 value) and a Zoo Family Membership (\$125 value) will be given to the winner.

You must fully complete and submit all non-optional data requested on the online entry form to be eligible. Incomplete entries are void.
