CONSIGNMENT TERMS AND CONDITIONS:

1. Consignment Client accepts full responsibility for tickets consigned during the regular season of March – November 2019. Statements will reflect the Consignment Client’s transactions and balance. The balance will be the net of all transactions recorded during that period. Consignment Client agrees to confirm the transactions and balance and report discrepancies immediately.
2. Consignment Client agrees to remit payment via by company/cashier’s check, or credit card by the first week of each month for tickets sold during the previous month at the cost per ticket as follows: **Adults (12-64) \$12.00; Children (2-11) \$10.00; Seniors (65+) \$11.00. Children under 2 are admitted free.**
3. Maryland Zoo Visitor Policy: Each ticket grants the holder entrance to the Zoo and /or event on the date indicated. The rules include, but are not limited to: no feeding the animals: no glass or alcohol: no bells, balloons, kites, Frisbees® or other objects intended to be thrown or flown: no bicycles, skates, skateboards or scooters; no solicitation without Zoo approval; and children under 15 must be escorted by an adult at all times. The Zoo is primarily an outdoors facility and the experience is greatly influenced by weather conditions. Refunds will NOT be issued based on weather conditions. The bearer of a ticket grants the Zoo the right to film,/videotape/photograph bearer on Zoo property for any purpose without payment or consideration therefore. Not all animals will be visible at all times. The holder acknowledges that the Zoo is a walking experience with hill containing carrying grades of incline, steps, curbs, doors, and sidewalks, roadways and pathways both paved and unpaved all of which may contain imperfections and additional physical challenges. Extreme caution and alertness must be utilized at all times.
4. At the time of a ticket reorder, Consignment Client agrees to be up-to-date with monthly payment. In addition, Consignment Client agrees to order a minimum of 25 tickets per order. Unused tickets must be returned to The Maryland Zoo by certified mail or personal delivery. Payment is required for all tickets sold.
5. **Regular Season 2019 consignment tickets will be valid from March 1, 2019 through November 30th, 2019.** Consignment tickets are valid for general admission any day that the Zoo is open in 2019. The Zoo is closed on Thanksgiving Day and Christmas Day. Cannot be combined with any other discounts, promotions and/or coupons. Purchase of this ticket may not be used towards membership or admission into special events that require a separate ticket purchase. Tickets are valid for entry into events included with Zoo admission, such as Bunny Bonanzoo and ZooBOOO!. **NO REFUNDS ACCEPTED.**
6. The Maryland Zoo reserves the right to recall any and/or all tickets at its discretion and to make specific changes to this agreement. In such event, the Consignment Client agrees to return all tickets immediately in his/her possession and make full payment for all unreturned tickets. Tickets must be returned by UPS, FedEx, certified mail or personal delivery.
7. The Maryland Zoo consignment tickets are not for commercial resale. In order to continue to provide your group with exceptional savings, tickets must be purchased for, and utilized by, members of your organization as listed on this order form. Tickets may not be sold on retail basis, and any sale outside the appropriate group is strictly prohibited.
8. In the event the Consignment Client does not meet all the stated terms and conditions, The Maryland Zoo reserves the right to cancel this agreement by written notice.

Consignment Client agrees to all foregoing terms and conditions, as indicated by the signature below. This agreement becomes effective when received and approved by The Maryland Zoo.
